ELIGIBILITY:

- AC Tune ups are available to Residential and Business customers with Central Air Conditioning units of 5 tons or less
- Tune up must be performed by a professional service technician within the calendar year and include the 12 point inspection completed (reverse page)

HOW TO APPLY:

1. To qualify for the \$25 bill credit, the applicant must meet all of the eligibility conditions and complete the application on the reverse side.
2. Attach the sales receipt (or a copy of the receipt) or paid invoice from a professional heating and cooling inspection and tune-up service.
3. The receipt or inspection documentation must indicate the date of service, dealer name, and an itemized list of service check-points, and any repair recommendations.
